Check in will be at the Mill Creek Grocery beginning at 5:00 am on Saturday 5/15/10. The Tournament will begin at 6:00 am. The launch at Mill Creek Park is available or you may trailer your boat to a different location after check-in and tournament start time (6:00am).

There will be a fish fry for those wishing to attend (Refreshments Provided) after the weigh-in is completed. Weigh-in will begin at 3:00 pm and you must be in line to weigh in by 4:00 pm. You must return to the launch ramp at Mill Creek Park or at the Mill Creek Grocery and report in prior to 4:00 pm or your catch will not be recorded.

NO FISHING WILL BE ALLOWED AFTER YOU REPORT IN.

ALL MONIES RECEIVED FOR TOURNAMENT ENTRY FEES WILL BE PAID OUT.

The big bass pot will be paid to the individual weighing in the largest bass and who has paid the \$10.00 big bass pot entry fee. Tournament entry fee is \$50.00 per team. You may pay the entry fee and big bass pot fees at check in (CASH ONLY - NO CHECKS) or prior to tournament day to the Treasurer at Orange S.O. Winnings will be given out after weigh-in is completed. (ANY PROTESTS OR CONTESTED WEIGHTS MUST BE MADE AT THE TIME THE WEIGHT IS ANNOUNCED TO THE TOURNAMENT DIRECTOR.)

TOURNAMENT RULES

1. AT LEAST (1) ONE MEMBER OF EACH TEAM IS REQUIRED TO BE EMPLOYED IN LAW ENFORCEMENT (Dispatchers, Corrections Officers, Constables, Police, Reserves, Deputy Sheriff's, Dept of Public Safety, Retired, etc...). ANY QUESTIONS OR REQUESTS CONTACT ONE OF THE BOARD MEMBERS OR TOURNAMENT DIRECTORS. TEAMS ARE LIMITED TO (2) TWO INDIVIDUALS.
2. ONLY (5) FIVE LARGE MOUTH BASS OR SPOTTED BASS PER (2) TWO MAN TEAM WILL BE WEIGHED IN. (You may have a total of 10 in possession and are encouraged to keep your limit for use at the fish fry). FISH WEIGHING IN OVER 5 LBS. WILL BE RELEASED BACK INTO THE LAKE. TEAMS THAT WEIGH IN DEAD FISH WILL BE PENALIZED ONE POUND ON THEIR TOTAL WEIGHT. FISH THAT ARE NOT 14 INCHES WILL NOT COUNT TOWARDS THE OVERALL WEIGHT. ALL CATCHES WILL BE SUBJECT TO INSPECTION AND APPROVAL OF THE BOARD MEMBERS IF DEAD.
3. TOURNAMENT START TIME IS 6:00am ON SATURDAY 05-15-10 AND ENDING TIME WILL BE AT 4:00 pm ON SATURDAY 05-15-10 AT THE MILL CREEK GROCERY.
4. ALL SAFETY EQUIPMENT REQUIRED BY LAW MUST BE IN YOUR BOAT AND MUST BE USED. ALSO LIFE JACKETS (PFD'S) MUST BE WORN WHEN OUTBOARD MOTOR IS IN OPERATION.
5. YOU MAY TRAILER YOUR BOAT TO ANY LAUNCH ON SAM RAYBURN LAKE FROM MILL CREEK GROCERY AFTER YOU CHECK IN AT 5:00 am WEIGH-IN WILL START AT 3:00 pm AND YOU MUST BE IN LINE TO WEIGH IN BY 4:00 pm (EVEN IF YOU HAVE NO CATCH TO WEIGH IN PLEASE REPORT IN SO WE KNOW YOU HAVE GOTTEN OFF THE WATER SAFELY.)
6. ENTRY FEES MAY BE PAID PRIOR TO THE DAY OF THE TOURNAMENT TO THE TREASURER OR IN CASH AT THE TIME OF CHECK-IN.
7. NO MEMBER OF ANY TEAM MAY BE A LICENSED FRESH WATER FISHING GUIDE OR EARN A PORTION OF THEIR INCOME FROM GUIDE FEES.
8. NO ALCOHOL CONSUMPTION PRIOR TO WEIGH-IN OF YOUR FISH.
9. ALL STATE AND LOCAL LAWS MUST BE OBEYED; VIOLATIONS OF ANY RULES WILL RESULT IN DISQUALIFICATION AND FORFEITURE OF TOURNAMENT ENTRY FEES.
13. NO LIVE BAIT WILL BE ALLOWED, ONLY ARTIFICIAL BAIT.
14. ANY REQUESTS, COMMENTS, AND QUESTIONS SHALL BE MADE TO THE BOARD FOR APPROVAL OR DENIAL.
