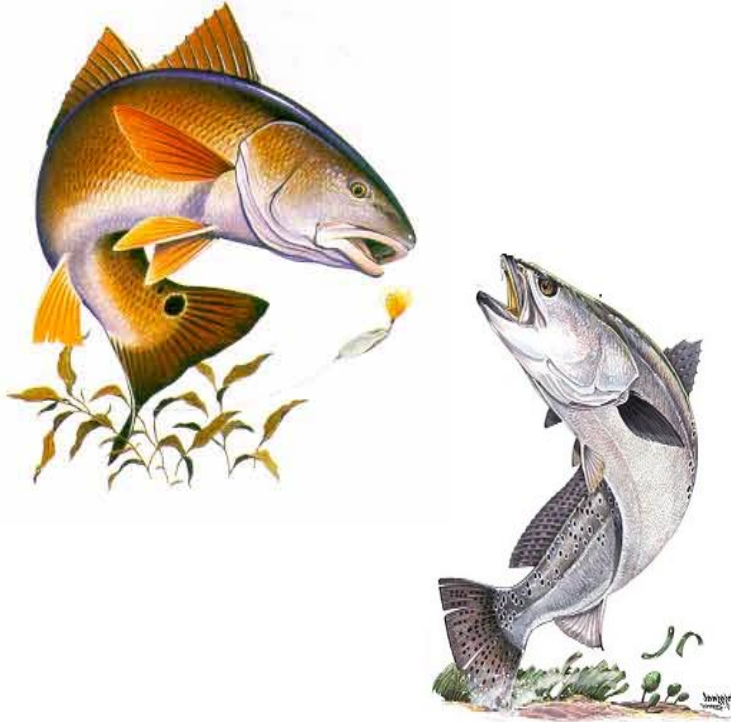

# ANNUAL C.C.L.E.A. Saltwater Roundup

## 2010 TEAM TOURNAMENT RULES

1. This tournament is open to Emergency Responder Personnel only. Non-personnel may fish provided one team member is an Emergency Responder. No professional fishing guides may participate.
2. This is a two person team tournament. If an angler wishes to fish alone the team fee will still apply. Each team will have a team name at registration and will be known by that name throughout the tournament. Be creative.
3. All State and Federal laws are to be obeyed. Weigh in will be conducted by C.C.L.E.A. designee.
4. Fishing boundaries are from the Aransas Wildlife Refuge, east to the Colorado River, and jetties. Fishing in the Gulf of Mexico is not permitted.
5. All fish must be caught by rod and reel method only. Fishing with live, dead, or artificial is permitted.
6. Contestants may begin fishing at 6:00 am and must be in line no later than 4:30 pm.
7. Weigh in will be held at the Port O'Connor Community Center in Port O'Connor Texas at State Highway 185E just outside of Port O'Connor. Official time will be kept by C.C.L.E.A. tournament officials.
8. Contestants may launch from any boat ramp provided they fish within said boundaries.
9. In case of a tie the winner will be determined by the length of the longest fish in that stringer.
10. Master Angler division will consist of a combined stringer of three Speckled Trout and two Redfish per team. No Redfish over twenty eight (28) inches and only one Trout over twenty five (25) is allowed.
11. Trout division will consist of no more than ten (10) trout and only one Trout over twenty five (25) inches will be allowed per stringer.
12. Redfish division will consist of three Redfish. No Redfish over twenty eight (28) inches permitted.
13. Any protests have to be made with tournament officials no more than ten minutes after weigh in is completed.
14. Violation of any rules will be an automatic disqualification and the violation is subject to be banned from any future C.C.L.E.A. tournaments.
15. All decisions made by C.C.L.E.A. are final.
